

## **Moama Anglican Grammar's Statement of Commitment to Child Safety**

Moama Anglican Grammar has developed the following Statement of Commitment to Child Safety as an overarching statement that provides key elements of our approach to protecting children and young people from abuse and sets the tone for the School's entire Child Protection Program.

It is designed to be Moama Anglican Grammar's public statement of commitment to child safety and a demonstration of the School's leaders' commitment to champion child safety in our School

It has also been approved and endorsed by the School Board and is regularly reviewed by the them.

The Statement is published on our public website as well as communicated through other mediums such as the Annual Report, Induction and Welcome Packs and all Staff contracts for School Board Directors, staff members, Direct Contact Volunteers and Direct Contact Contractors.

### **Objectives**

This Statement provides the framework for:

- the development of work systems, practices, policies and procedures that promote child protection, safety and wellbeing within the School
- the creation of a safe and supportive School environment and a positive and robust child protection culture
- the promotion and open discussion of child protection issues within the School
- complying with all laws, regulations and standards relevant to child protection in NSW.

### **Statement of Commitment**

Moama Anglican Grammar is committed to providing education and care to children and young people to assist them to develop into high-achieving, supported students, positively connected to each other and to the communities in which they live and which they will serve.

The School is committed to ensuring the safety, welfare and wellbeing of all children and young people at the School and is dedicated to protecting them from abuse and harm.

At Moama Anglican Grammar, we have a zero tolerance for child abuse. The School regards its child protection responsibilities with the utmost importance, and as such is committed to providing the necessary resources to ensure compliance with all relevant child protection laws and regulations and to maintain safe and supportive School physical and online environments for all children and young people.

### **Child Safe Values and Principles**

The following child safe principles guide the School's commitment to child safety and form the basis for all child protection policies and procedures at the School.

1. All children and young people have the right to be safe and treated fairly.
2. The welfare and best interests of children and young people are paramount.
3. The views and the privacy of children and young people must be respected.

4. Clear expectations for appropriate behaviour with children and young people are established in our Child Safety Code of Conduct and Staff and Student Professional Boundaries policy.
5. The safety of children and young people are dependent upon the existence of a child safe culture.
6. Child safety awareness is promoted and openly discussed within our School community.
7. Procedures are in place to screen all staff, Volunteers, Third Party Contractors and External Education Providers who have direct contact with children and young people.
8. Child safety and protection is everyone's responsibility.
9. Child protection training is mandatory for all School Board Directors, staff members and Direct Contact Volunteers.
10. Procedures for responding to alleged or suspected incidents of child abuse and harm are simple and accessible for all members of the School community, and all are welcome and encouraged to use them.
11. Procedures are in place to ensure all School premises are designed to ensure the safety of children.

### **Child Protection Officers**

As part of our commitment to child safety and protection, Moama Anglican Grammar has appointed Child Protection Officers as honest, mature, ethical and experienced members of the School community who can deal with sensitive issues relating to child protection and safety.

### **Responsibilities**

The School acknowledges that child protection is everyone's responsibility.

At Moama Anglican Grammar, all directors of the School Board, staff members, Volunteers, Third Party Contractors and External Education Providers have a shared responsibility for contributing to the safety and protection of children and young people.

### **Reporting Child Protection Concerns**

Our Child Protection Program provides detailed guidance for all members of the School community as to how to identify key risk indicators of child abuse and how to report child abuse concerns to one of our School's nominated Child Protection Officers. It also contains detailed procedures with respect to the reporting of child abuse incidents to relevant external authorities.

Staff, Volunteers, Third Party Contractors, External Education Providers, students, parents/carers or other community members who have concerns that a child or young person may be subject to abuse are asked to contact one of the School's Child Protection Officers.

Communications will be treated confidentially on a 'need to know basis'.

Whenever there are concerns that a child is in immediate danger the Police should be called on 000.

Moama Anglican Grammar is committed to the continuous improvement of our Child Protection Program and to ensuring the School's compliance with NSW child protection law and regulation.

The Program is regularly reviewed for overall effectiveness and to ensure compliance with all child protection related laws, regulations and standards.
